We understand that a Presidential Executive Order could be issued at anytime by the

President to revoke the government's charter and involvement with the private Corporation for Public Broadcasting (cpb.org). We also understand a separate order was already given for 1,000 military personnel to head over to the CPB offices at 401 9th Street, NW to clean their offices out.

Ahead of the actual President Executive Order (should the President decide to issue it), please consider the following so the current CPB's ISIS (<https://isis.cpb.org>) system can be flushed as it will be transferred over to a new Stations portal that matches all of the numbers as reported by the Small Business Administration for inclusion and numbers reported accurately to the American people on a new U.S. Department of Public Broadcasting website:

1. The creation of the U.S. Department of Public Broadcasting.
2. A new charter to be established for the U.S. Department of Public Broadcasting.
3. The creation of the dpb.gov domain.
4. A new website for <https://www.dpb.gov> will also need to be created.
5. A new portal for <https://www.dpb.gov/stations> will also need to be created. Every non-commercial educational (NCE) station (irregardless of geographic location and size) will be issued a Stations portal account for inclusion.

With the \$30 Million allocated for this undertaking by the President, we'll need the GSA's assistance to create this new government institution (only publicly funded) as the DC Swamp continues to get drained.
